## *The Nashville Area Order of St. Andrew Endowment*

A special interest restricted endowment fund, to be known as the Nashville Area Order of St. Andrew Endowment Fund has been established by the United Methodist Foundation for the Memphis & Tennessee Conferences to honor ministers and laity of the Memphis and Tennessee Annual Conferences of the United Methodist Church who have served faithfully and blessed the lives of individuals in the churches they have served. The income from the Fund will provide scholarships for individuals pursuing pastoral ministry and enrolled in a seminary.

### *Andrew*

Andrew was known as “the bringer”. All he did was bring his brother, Peter, the little boy with the five loaves and fishes, and the Greeks to Jesus. He was just an ordinary person, but Jesus saw in him something that others did not see. He never wrote a book, was never elected to office, never became bishop, or never painted a picture. He just brought people to Jesus.

The Nashville Order of St. Andrew Fund was established by the United Methodist Foundation for the Memphis & Tennessee Conferences after the Visioning Committee learned of the Dickson Order of the Mississippi Annual Conference of the United Methodist Church. The Nashville Area Order of St. Andrew Fund was established to honor ministers and laity who were “Andrews” for countless souls across the Memphis and Tennessee Annual Conferences.

## *Membership in the Nashville Area Order of St. Andrew*

Individuals, churches, Sunday School classes, or organizations wishing to bestow this honor upon a minister or laity must make a contribution of at least one thousand, two hundred and fifty dollars (\$1,250) to the Fund. Eligibility for the membership in The Order is open to all ministers who are or have been an Elder, a Deacon, an Associate Member, or a Local Pastor and all laity in the Memphis or Tennessee Annual Conferences.

Recognition of this honor will be made known at the sessions of the Memphis and Tennessee Annual Conferences. A plaque with a representation of the honored minister or laity will be presented to the recipient or his/her family. Another plaque will be placed at the respective Conference offices of the Memphis and Tennessee Annual Conferences.

The donors and any others desiring to do so may make additions to the Fund in any form acceptable to The United Methodist Foundation for the Memphis & Tennessee Conferences, by current or deferred gifts, devises, bequests, etc., at any time and from time to time, provided that any person or persons so making additions to the Fund shall be bound by the terms of the Endowment Agreement.
