

#### To Donors, Supporters, and Friends:

You are receiving this letter as a means of sharing current information about, expressing gratitude for, and providing assurance regarding gifts relating to Martin Methodist College ("MMC"). MMC's journey has been filled with change, anticipation, and ultimately...HOPE!

As many of you know, in 2021, MMC entered into an agreement with the University of Tennessee ("UT"), whereby UT acquired most of MMC's physical assets and began to operate the University of Tennessee-Southern ("UTS") on the former MMC's campus. This arrangement allowed the beautiful and historic campus to maintain its foundational presence as a part of the fabric of Pulaski, while providing a dynamic option for degree-seeking students in the South Central Tennessee region and beyond.

While substantially all of MMC's physical assets were transferred over to UT during this transition, MMC retained all of its endowment assets, including gifts and scholarship funds previously established by its donors. While MMC ceased to operate as a college, it has continued to exist in order to faithfully steward these remaining assets. In recognition of this continued work, MMC changed its name to Martin Methodist Foundation ("MMF").

Many endowment assets contained donor restrictions that were specific to MMC's college operations. Because MMC ceased to operate as a college, and because UTS is not affiliated with the United Methodist Church, it became impossible or impracticable to administer these funds in accordance with their original restrictions. Accordingly, following the transition, MMF began to collaborate with UTS, the United Methodist Foundation for the Tennessee-Western Kentucky Conference (the "Foundation"), and the Tennessee Attorney General on modified uses for its endowment funds.

In April 2024, with the approval of the Davidson County Probate Court, MMF and the other parties agreed to a plan wherein MMF's endowment funds were repurposed in largely two ways: First, funds containing expressed faith-based restrictions (e.g., scholarships for church-specific majors) were combined and modified so they could be used to provide scholarships for certain United Methodist students and students attending United Methodist-related higher education institutions. Second, funds not containing expressed faith-based restrictions (e.g., scholarships based on grades) were combined and modified so they could be used to provide scholarships to students attending UTS. Following these modifications, after ardent prayer and careful fiduciary consideration, MMF voted to delegate the management, investment, and distribution of its endowment to the Foundation.

These actions have enabled MMF to better invest its endowment funds and to make them more available for student support. MMF aims to continue to support higher education in such a way that honors MMC's legacy and community.
